Joseph John William, Anna Conyngham's husband was the son of Anton Williams. Anton was born March 4, 1846 in Azores Islands of the Kingdom of Portugal. I don't know the exact date of his arrival in the U.S. or what port he arrived at. He states in his Application for citizenship that he arrived in 1871.

He married (at St Andrews Church in Cici) Anna Ennis (I have found three spellings of this name Enos, Enis Ennis, & Her death certificate has Enos.) on Sept. 28, 1874. She was born in Providence, R.I. on July 19, 1858, the daughter of Joseph and Isabel Enos. They were both born in Portugal.

The Williams family name in Portugal was Mello. (Melo. De Melo?)

years last past; that he was born in the year 1846 in London the Western Islands
that he emigrated to the United States in the year 1871; that on the 25 day of Aug
1876 he filed in the Court of Common Pleas of Erie County, Pennsylvania, a declaration of his intention to
become a citizen of the United States; that he has been a resident of the United States for more than five
years immediately previous to this application, the last year of which he has resided in the Commonwealth
of Pennsylvania; that he has never borne any hereditary title or been of any of the orders of nobility, and if
any such should by any means descend to him, he doth hereby absolutely and entirely renounce the same; that
he has never been proscribed by any state; that your petitioner is desirous of becoming a citizen of the United
States, and to enjoy the benefits of the constitution and laws thereof.

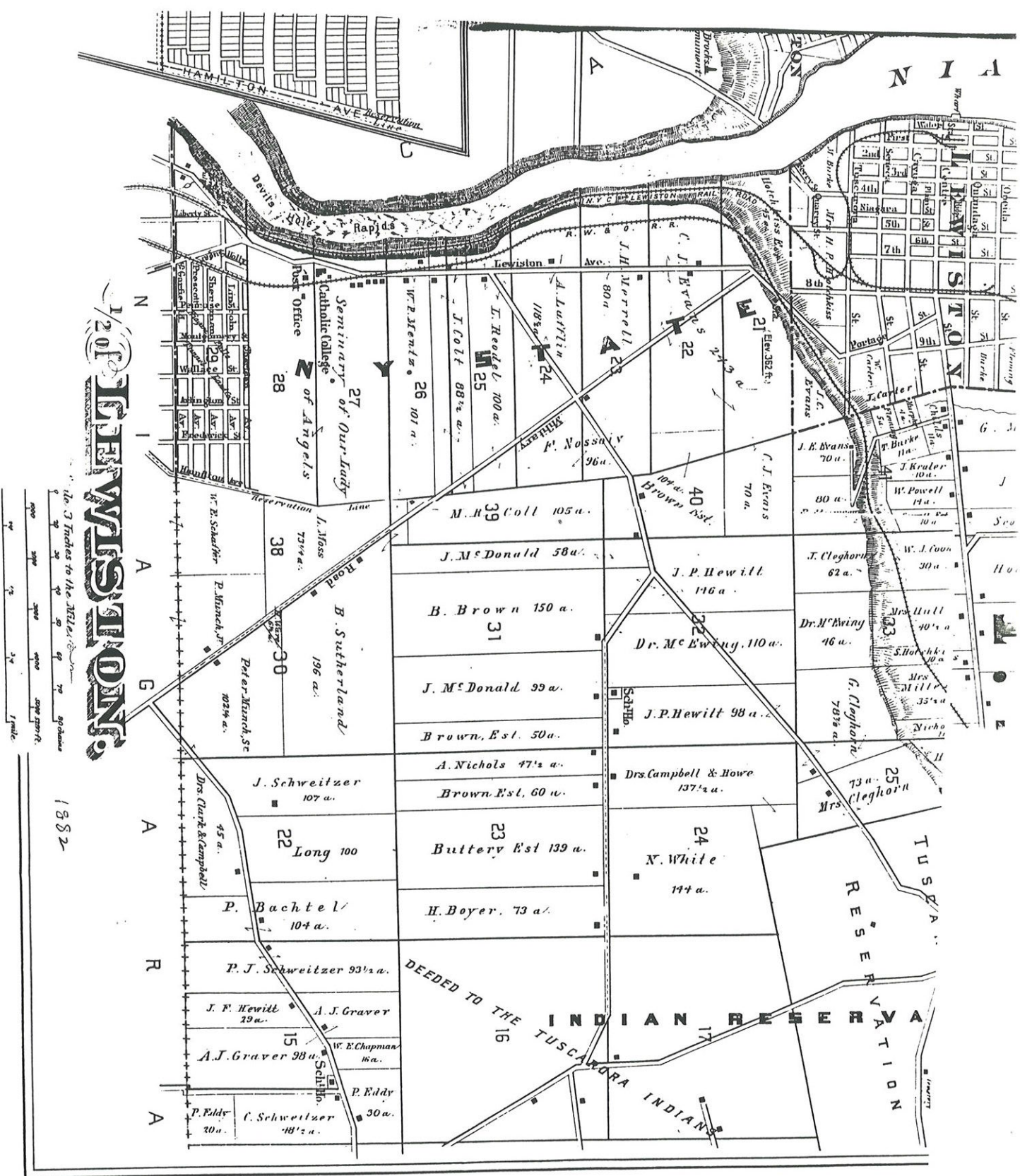

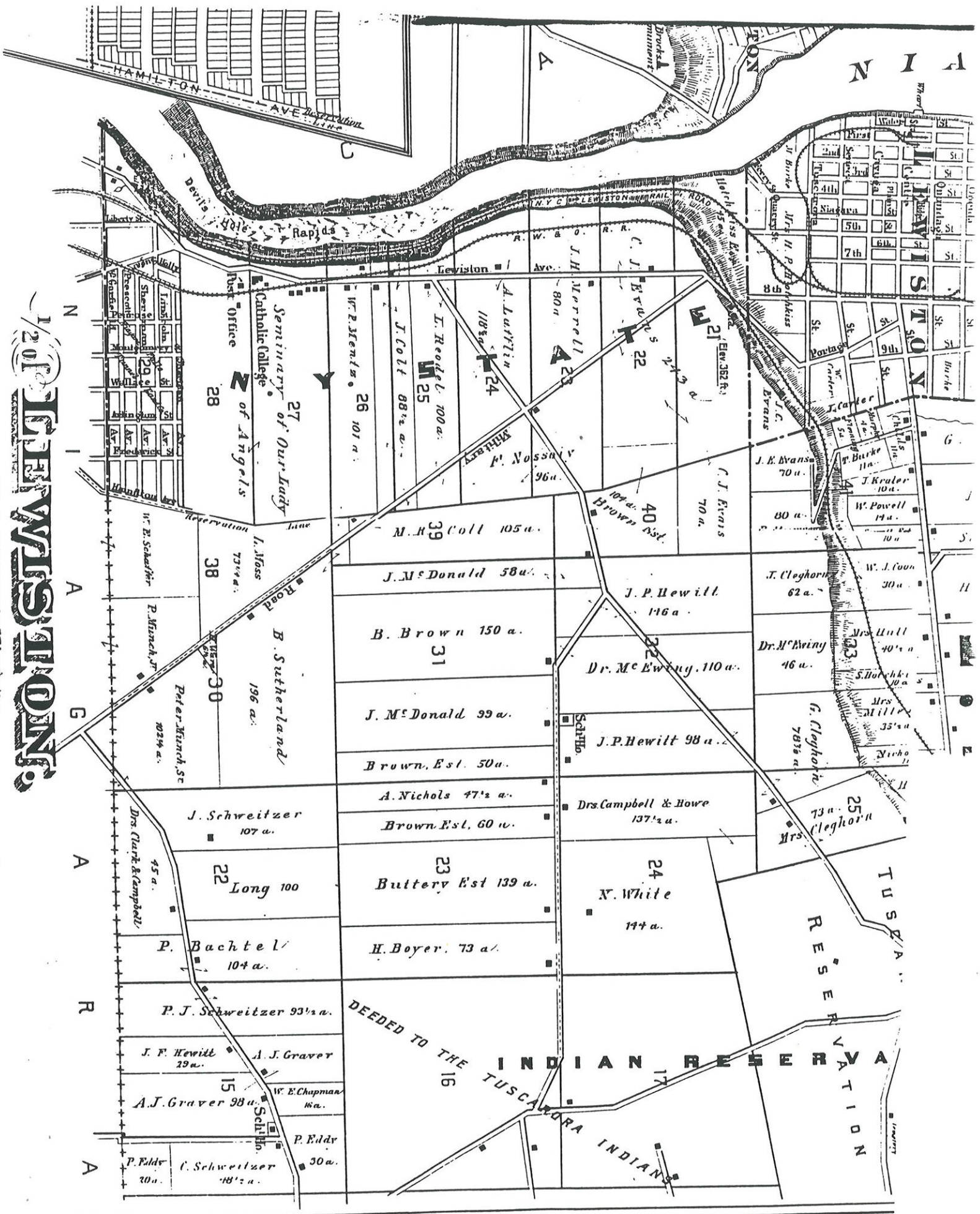
